Mission Statement

New Orleans Baptist Theological Seminary and Leavell College prepare servants to walk with Christ, proclaim His truth, and fulfill His mission.

Core Value Focus

The seminary has five core values.

- 1. Doctrinal Integrity:** Knowing that the Bible is the Word of God, we believe it, teach it, proclaim it, and submit to it. This course addresses Doctrinal Integrity specifically by preparing students to grow in understanding and interpreting of the Bible.
- 2. Spiritual Vitality:** We are a worshiping community emphasizing both personal spirituality and gathering together as a Seminary family for the praise and adoration of God and instruction in His Word. Spiritual Vitality is addressed by reminding students that a dynamic relationship with God is vital for effective ministry.
- 3. Mission Focus:** We are not here merely to get an education or to give one. We are here to change the world by fulfilling the Great Commission and the Great Commandments through the local church and its ministries. This course addresses Mission Focus by helping students understand the biblical foundations for fulfilling the Great Commission and the Great Commandments.
- 4. Characteristic Excellence:** What we do, we do to the utmost of our abilities and resources as a testimony to the glory of our Lord and Savior Jesus Christ. Characteristic Excellence is addressed by preparing students to excel in their ability to interpret Scripture, which is foundational to effective ministry.
- 5. Servant Leadership:** We follow the model of Jesus and exert leadership and influence through the nurture and encouragement of those around us. Servant Leadership is modeled by classroom deportment.

The core value focus for this academic year is *Mission Focus*.

Curriculum Competencies

NOBTS faculty members realize that all ministers need to develop specific competencies if they are going to have an effective ministry. To increase the likelihood of NOBTS graduates having

an effective ministry, the faculty developed a competency-based curriculum after identifying seven essential competencies necessary for effective ministry. All graduates are expected to have at least a minimum level of competency in all of the following areas:

1. **Biblical Exposition:** to interpret and communicate the Bible accurately.
2. **Christian Theological Heritage:** To understand and interpret Christian theological heritage and Baptist polity for the church.
3. **Disciple Making:** To stimulate church health through mobilizing the church for missions, evangelism, discipleship, and church growth.
4. **Interpersonal Skills:** To perform pastoral care effectively, with skills in communication and conflict management.
5. **Servant Leadership:** To serve churches effectively through team ministry.
6. **Spiritual and Character Formation:** To provide moral leadership by modeling and mentoring Christian character and devotion.
7. **Worship Leadership:** To facilitate worship effectively.

The curriculum competencies addressed in this course are: Servant Leadership, Discipleship, and Interpersonal Skills.

Course Description

This course is an introduction to social work practice with communities with special attention given to evaluation of community methods of intervention, community study and planning, professional role with community committees and representation, differential aspects of the community organization method, and emerging trends of theory and practice. The church's role in the community is emphasized.

Student Learning Outcomes

Upon completion of this course, a student should be able to:

1. Examine the church's role in the community.
2. Select appropriate interventions for use in community practice.
3. Identify current models of social work practice with communities
4. Assess the dynamics of oppression and discrimination within organizations and communities.
5. Value social work ethics related to communities.

Course Teaching Methodology

This course will be taught using in-class lecture, discussion, class exercises, and case studies.

Course Requirements

I. Synthesis Paper

Due: November 10

The synthesis paper is a 15 page paper (exclusive of Title Page and Bibliography, in which you take a specific social problem, apply a specific macro social work intervention (or several interventions) and situate them within a Judeo-Christian worldview. Students should use no fewer than 15 sources, exclusive of required textbooks. The goal of the paper is to apply learning from the class, integrate outside sources and social thinking and arrive at a solution to a social problem of your choosing. (Submit on Blackboard.)

II. Reading Assignments

During the course of the semester, students will have 6 assignments related to reading that will be submitted in class. See the schedule for due dates.

III. Exams

Students will complete midterm and final exams.
