New Orleans Baptist Theological Seminary and Leavell College prepares servants to walk with Christ, proclaim His truth, and fulfill His mission.

Purpose of the Course:

The purpose of this course is to provide an integrated social work experience for students in chosen placements (churches or agencies) working in a professional setting under supervision of two supervisors: agency and seminary.

Core Value Focus:

The course will emphasize the seminary's current core value focus assigned annually by the Administrative Council. For the 2020-2021 academic year, the core value is **Mission Focus**.

1). **Doctrinal Integrity** – Knowing that the Bible is the Word of God, we believe it, teach it, proclaim it, and submit to it. The doctrinal statements used in our evaluations are our Articles of Religious Belief and the Baptist Faith and Message Statement.

2). **Spiritual Vitality** – We are a worshipping community, with both personal spirituality and gathering together as a Seminary for the praise and adoration of God and instruction in His Word.

3) **Mission Focus** – We are not here merely to get an education or to give one. We are here to change the world by fulfilling the Great Commission and the Great Commandments through the local church and its ministries.

4) **Characteristic Excellence** – What we do, we do to the utmost of our abilities and resources as a testimony to the glory of our Lord and Savior Jesus Christ.

5) **Servant Leadership** – We follow the model of Jesus and exert leadership and influence through the nurture and encouragement of those around us.

Curriculum Competency Addressed

This course will address the following curriculum competencies:

1) Interpersonal relationships: Students will be able to demonstrate that they are able to practice listening skills, assertiveness skills, conflict resolution skills, collaborative problem-solving skills and skills selection

2) Servant leadership: Students will learn and practice Christ's model of service to individuals in need while learning critical leadership skills that will guide their future social work practice.

3) Spiritual and character formation: Students will demonstrate an ability to integrate and utilize Christian and professional ethics for professional decision making and personal character development.

Course Description

Students are involved in the practice of social work under supervision for eight hours per week. Experiences of the student vary according to the field placement. Students gain real-world experience in Baptist centers, social service agencies and church settings. This course is limited to students specializing in Social Work. Each student must consult with the professor prior to registering for the practicum. Prerequisite: CESW6360 Introduction to Social Work.

Student Learning Outcomes

In order to serve effectively in a generalist social work environment, the student, by the end of the course, should:

1. Be able to apply theoretical social work concepts acquired in previous classes to real-world needs in a social work practice environment.
2. Demonstrate the ability to work satisfactorily and appropriately in a professional social work setting.
3. Apply professional ethical values of Christian social work in a real-world setting.

Students will present cases drawn from supervised field placement to explore social work practice issues. Students will also discuss ethical dilemmas faced by social workers as they engage in clinically sound social work practice.

Note: The professor reserves the right to make adjustments in the schedule as needed.

Teaching Method: Lecture, discussion, presentation of cases, journaling, group experiences and supervisory experiences within an agency and with the professor. Final Exam will be an oral exam.

Assignments and Evaluation Criteria:

Class Format: Students will meet for one hour weekly with the professor for group supervision. The time will be negotiated with the students. Students will lead discussions of texts and present cases. Each student is required to meet individually on a virtual basis twice during the semester with the seminary supervisor. The first of these will occur during the first week of classes. The final meeting will be the last week of classes. The focus of these meetings will be preparation and evaluation of the practicum experience. A written evaluation will be part of the final exam.

Practicum Journal: The student will record detailed accounts of their practicum experience, including activities, responsibilities, questions, feelings, discussions, supervision and evaluations. In addition to a narrative of the week's experience students will write one paragraph expressing and analyzing his/her thoughts about the week's experience, showing reflection upon the experience. Students will also journal at least one paragraph expressing his/her feelings about the week's experience. Be patient with yourself and honest. Be careful not to write what you think you "should" feel unless you carefully identify this distinction. Share reactions, opinions and questions. Individual journals are to be submitted each week to the professor's email on Tuesday and will be returned with feedback on the following Wednesday. Journals submitted after that time will be considered late and will be graded a C (84) or below.

Reading Assignments:

Journal Assignments:

Students are expected to give the weekly journal to the professor no later than Tuesday at noon, see policy on late assignments.

Professor's Policy on Late Assignments:

All work is due at the beginning of class on the assigned day. The highest grade a late assignment can receive will be no higher than a C (84). Assignments that are over one week late will not be accepted.
