Course Description

Leadership principles, philosophies, hazards, and trends are investigated through research and lectures. Papers are presented and discussed, and several leadership theories are evaluated. Of particular is an integration of sound business practice and Christian leadership in the local church. This course is part of the required rotation in the PhD in Christian Education.

Course Objectives

Upon the successful completion of the course the student should be able to:

1. Define leadership and explain various theories of leadership with particular focus on leadership that is Christian.
2. Describe the effect of variables such as power, authority, conflict, organizational climate, and purpose on the practice of leadership.
3. Illustrate the managerial process of leadership and discuss the functional areas of decision making, communication, motivation, staff selection, and staff development.
4. Examine the implications of purposeful leadership in the growth and effectiveness of the local church, particularly in regard to the educational ministry..
5. Complete and evaluate various instruments to assess personal leadership styles and strengths.

Class Requirements

1. Textbook Readings: All students are to read all the textbooks. Each student will facilitate a discussion of one of the books. This discussion should be designed to focus on reactions to the readings and search for application. We will read a book every other week. **A threaded discussion on Blackboard will precede your discussion in seminar. The assigned student will initiate conversation on the thread and everyone else will need to contribute at least three substantive entries to each thread (in other words, not “yeah, me too.”).**

2. Interview: Each student will construct an interview of not less than 10 and not more than 20 questions designed to get advice from someone you consider a leader. The questions can cover a specific area (e.g. conflict resolution) or be more general (e.g. leadership qualities needed to lead a single-staff church). Once the interview questions are compiled and the interview is conducted, students will type a verbatim of the interviewee's responses.
3. Ministry Insights Tool: Any time after you get your password from Dr. Jackson, you may go online to take the assessment. Print the report that is available when you finish, and write a 3-page reaction. Include whether or not it describes your leadership style (you might ask someone close to you to read it as well) and what that might mean for you as you take a place of leadership in a local church, agency, or denominational setting. If you are really feeling enlightened, you might also add a paragraph as to implications in your family.
4. Leadership biographies: Each student will locate a biography of a well-known leader in either the Christian or secular world. Biographies I have read lately include Rudy Guiliani, John Adams, and Oswald Chambers, Dave Dravecky, Stonewall Jackson. Prepare a 1- page “talking points” summary of the book. This summary will contain a brief biographical sketch of the author, the subject, and a listing of several major “ah-ha moments” for you as you read about his/her life. You will share your insights on this leader when we get together.
5. Research Paper: Each student will develop a research paper on an assigned topic dealing with leadership and present a 40 minute oral presentation based upon the research. The paper should include
 - a. A biblical rationale for leadership in general as it relates to the particular area of study, including examples and text references
 - b. A complete discussion of a leadership theory, principle, paradigm, or practice
 - c. Biblical examples illustrating the specific leadership principles discussed.
 - d. Specific implications for the local setting

The paper is to be 30-40 pages in length, ***with the last 8-10 pages specifically dealing with the implications for the topic as it relates to the local church.*** A copy of the paper will be distributed to the seminar one week prior to presentation via e-mail attachment (use .rtf format). The seminar presentation of the research will be a creative presentation and not a recitation of the paper. It should seek to involve seminar participants in a meaningful way with the information discovered in research. The presentation will be a maximum of 40 minutes in length, leaving 20 minutes for response and reflection.
